RELEASE FROM LIABILITY AND ASSUMPTION OF RISK AGREEMENT

I, (please print) _____, acknowledge that I have volunteered without pay on the construction site and in other activities with the Texas Ramp Project. I understand that these activities are not conducted in the course of trade or commerce and do not involve the lease or sale of goods or services.

I am aware that construction is a HAZARDOUS ACTIVITY. I am voluntarily participating in the activities of construction, which include but are not limited to, the construction of wheel chair ramps at residential buildings, loading and unloading materials, framing, transporting to and from building sites, use of power tools, and other related activities with the knowledge of the hazards, risks and danger involved, foreseen or unforeseen, and with the knowledge that medical facilities may not be available in the event of illness or injury to myself. I hereby agree to accept any and all risk of injury, illness or death and verify this statement by placing my signature below.

As consideration for being permitted by Texas Ramp Project to participate in the activities and use their tools and facilities, I hereby agree that I, my assignees, heirs, distributees, guardians and legal representatives will not make a claim against, sue or touch the property of Texas Ramp Project and its current or future directors, officers, agents, employees, volunteers, suppliers, contractors, or subcontractors for injury, illness or damage resulting from my participation in Texas Ramp Project activities. I HERBY RELEASE TEXAS RAMP PROJECT FROM ALL ACTIONS, CLAIMS OR DEMANDS THAT I, OR MY REPRESENTATIVES, NOW HAVE, OR MAY HEREAFTER HAVE, FOR INJURY, DEATH, OR DAMAGE RESULTING FROM MY PARTICIPATION IN TEXAS RAMP PROJECT ACTIVITIES INCLUDING ACTIONS, CLAIMS, OR DEMANDS RESULTING IN WHOLE OR IN PART FROM THE NEGLIGENCE OF TEXAS RAMP PROJECT, OR ITS CURRENT OR FUTURE DIRECTORS, OFFICERS, AGENTS, EMPLOYEES, SUPPLIERS OR CONTRACTORS. THIS RELEASE IS INTENDED BY BOTH PARTIES TO BE BROAD IN ITS EFFECTS.

I understand that the foregoing release and assumption of risk is intended to be as broad and inclusive as is permitted by the law of the State of Texas and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I further understand that Texas Ramp Project is a fully volunteer staffed company that is in no way responsible for my actions or the actions of the current or future agents or employees of Texas Ramp Project. I understand that Texas Ramp Project has no duties or obligations to provide or implement any safety policy or safety training to the volunteers, including myself, for participation in construction site projects for Texas Ramp Project.

I have carefully read this Release from Liability and Assumption of Risk Agreement. I fully understand its contents and terms. I am aware that this is a release of liability and a legal contract between me and Texas Ramp Project and that it affects my legal rights. I understand that, by my signature below, I am giving up substantial rights, including my right to sue. I am signing this document voluntarily, of my own free will, and as a complete and unconditional release of all liability to the greatest extent allowed by law.
